RESPONSE TO COVID-19 at BPPL-SPM

Since the occurrence of first COVID-19 case, the entire world is continuously taking due measures. Situation became more serious once the World Health Organization (WHO) has determined the Coronavirus disease 2019 (COVID-19) as a pandemic on 11 March 2020.

Under the guidelines of International organizations, instructions promulgated by Government officials and Industry best practices, BYCO Petroleum Pakistan Limited (BPPL) has taken number of steps as safety precautions. Few highlights at BPPL – SPM site are as under:

A. SPM – ZP (Shore site):

a. Compliance Of AHR Recommendation

Following steps taken at SPM site under the BYCO Guidelines - Pandemic Response by VP AHR (dated 17th and 22nd March 2020):

- Encourage Work from home to minimum interaction of people, as applicable.
- Provide specialized mask N-95, surgical mask, hand Gloves, apron etc. as PPE compliance.
- Limit number of persons in pool transport with compulsory use of facemask.
- Place hand sanitizers in appropriate places & promote hand washing culture at site.
- Perform Thermal scanning of all individual at main gate entry as defensive actions.
- Display COVID-19 awareness poster by BYCO Clinic and BIMCO (maritime) at noticeable places.

b. Additional Steps

- Issued Safety Bulletin on 'Hygiene Requirement- COVID-19 Pandemic' dated 31st March 2020.
- Conducted Awareness session on 'Health and Personal Hygiene COVID-19' on 18th and 21st April with participation of concern staff.
- Routine rounds at SPM site with particular attention to health and hygiene matter.
- Increased cleaning and disinfection daily cycle at SPM site office block, pantry and other associated places.
- Provided assistance in SPM site visit to representative of Disinfection services (Pakistan Facility Management). Contract is under process to disinfect the site.
- Replacement of Hand scanning attendance to latest Retina scanning to mark attendance.

B. <u>SPM – OFFSHORE SITE:</u>

a. EHS ADVISORY

- Addressed and update the guidelines to SPM off-shore by EHS-Advisory:
 - EHS ADVISORY (Issue #02) dated 30th January 2020 on COVID-19. Precautionary measures as advised by WHO and Ministry of Maritime Affairs, Govt. of Pakistan circulated to all concerned.
 - Revised EHS ADVISORY (Issue #02-A) dated 13th March 2020 on COVID-19. Precautionary measures enhanced as the WHO declares COVID-19 as pandemic on 11th March 2020. This issue include the reference of IMO-Circular No.4204 and WHO-Operational considerations for managing COVID-19 cases/outbreak on board ships
 - Revised EHS ADVISORY (Issue #02-B) dated 01st April 2020 on COVID-19. It covers the more stringent steps taken by Ministry of Maritime Affairs, Govt. of Pakistan to combat the potential risk associated with COVID-19.

b. Off-shore Movements and guiding principle

- Restricted minimum off-shore movements from ZP as advised by HoD-SPM operations.
- Implemented Thermal scanning of all individual in each off-shore movements from SPM- ZP as cautionary procedures.
- Compliance of Maritime port health policy in off-shore movement from KPT.
- Off-shore contractor (Smith Lamnalco) is in close coordination to ensure safety precautions in contractual crafts.
- All ships at SPM Port terminal premises and off-shore contractual crafts are strictly instruct to keep monitoring the crew's health and should report immediately in case of any abnormality.
- Preferred minimum interaction of shore and off-shore individuals and if deemed essential social distance practice must be observed.
